Retail Crime Free

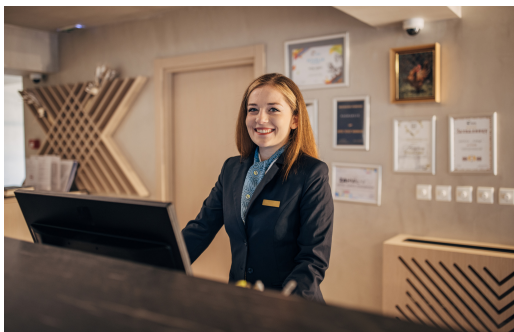
